



CWSR 2014 - 2015 Annual Progress Report

Projects:

- Charles James received his re-appointment letter as curator of the California Well Sample Repository from HR on June 15, 2015. The position will continue thru June 2016.
- Continue the reorganizations of core in both buildings
- Add 2,000 files to the Mount Diablo log collection
- Working to separate out-of-state Superior sample material for possible donation to other repositories out of state.
- Safety Check completed for: warehouse lighting and secured warehouse storage racks
- Chevron Well File Data sourcing project, 688 file boxes to Kern River for scanning.
- Material relocation project in building B added storage space for approx 1000 boxes
- Andrea Weikel continues to help with project support duties to repository curator.

New material to be added to inventory:
